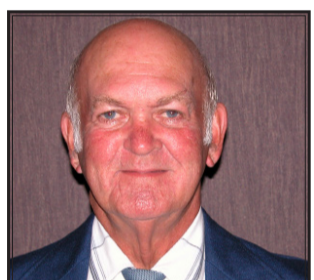
## **GARRY WALSH**

Qualified Fitter and Machinist, Aircraft Fitter, Boiler Attendant, statement of attainment in Manufacturing and Engineering.



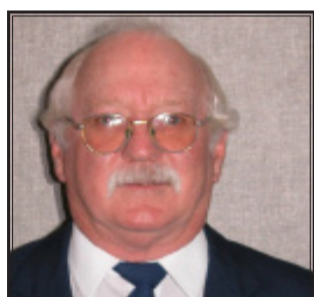
## **BARRY REMMINGTON**

Vice Captain of Golf Club in 1976, Handicapper from 1982-present. Committee member Outdoor Bowls Club.



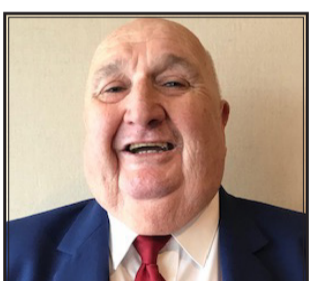
## **GEOFF TROY**

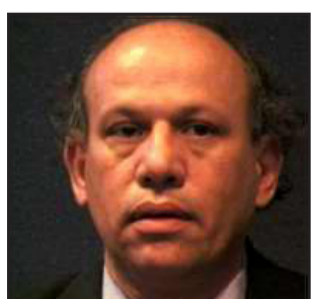
## **DENNIS QUINLAN**
